We will talk about creating a plan for congregants to meet with Board Leadership and Finance Committee leadership to create a solution. These meetings will take place over the last half of 2018.

We will be sharing more information about the return of our Leadership Development program Atidaynu: Our Future, talking about volunteer opportunities at the Temple, as well as having an update from Religious School.

## Semi-Annual Meeting Minutes December 9, 2017

Meeting called to order: 4:57pm

Mark Bresnick thanked everyone for attending and asked people to send him feedback on what they think of this format.

We reviewed the minutes on the screen. We will send these out for approval after the meeting. For future meetings we will send them out ahead of time for the next meeting.

Bob Goodmark gave an update on Finance. We currently have a small budget surplus (which is usual for this time of year). There was a net of \$12k last year and we fully funded the emergency fund and put the surplus in the Reserve fund. The property loans were paid off in June and the properties have had a positive cash flow this year. There is still an open question on what we do with the duplex. We have given more than \$3k in Religious School scholarships this year leaving only \$400. The rest is coming out of general donations. The Wexler's made a generous donation to fund an endowment for High Holiday music. Life and Legacy has a target of 18 for this year and we have 5 so far. The endowment fund will be listed so others can donate to the same fund.

Heidi Piel gave a quick reminder about the "non-event" fundraiser.

There was a raffle for the 2 parking spaces. The Wexlers and the Goodmarks each paid \$800.

Glenn Pickus gave an update on the Rabbinic search. Our application has been submitted and we've received 7 resumes. 6 have been reviewed so far and interviews and reference checks are in progress. Visits to our congregation will be in January or February. There is at least one candidate who looks very good so far. None

of the current applicants are new graduates. The matching process for students comes later in the year. Interviews are being done electronically. Candidates are not allowed to lead services but can come for educational discussions. There is a request to live stream or record these sessions for those who are unable to attend. We will give several weeks of notice to the congregation so people can plan on attending.

Al Friedman told us that the URJ is changing providers for web sites and he is working on an updated site. He expects to complete it by January 1.

Mark recognized people for volunteering.

We had an election for certain board positions (listed above). Nancy moved we approve the slate of candidates. Eldon Wexler seconded. The candidates were approved unanimously.
