Rabbi's Corner



Sabbatical: A time to regenerate and grow

The concept of sabbatical is discussed in the Torah. The Book of Exodus teaches: "For six years you are to sow your land and to gather in its produce, but in the seventh, you are to let it go and to let it be" (23:10-11). In order for the land to regenerate and continue to grow, it needs to lay fallow. Back in ancient Israel, all of our ancestors were subsistence farmers. In addition to the land resting, our ancestors would have enjoyed time off from tending their fields. I wonder how they used the extra time in their seventh year?

This is my seventh year serving as rabbi at Temple Beth Or. I am incredibly grateful to my Temple Beth Or community for supporting my six-month sabbatical beginning in January. Just like the agricultural sabbatical described in the Torah, growth and rejuvenation are my core goals for my seventh year as your rabbi.

As many of you know, my daughter Galit and I will live in Jerusalem. I look forward to sharing a taste of my time there with you, once a month on Shabbat over Zoom. But before I leave, I want to share seven things I hope to accomplish during my sabbatical.

- 1 **Refill my "box" of Jewish texts.** I am looking forward to reading Jewish books I've been meaning to read, like Rabbi Shai Held's *Judaism is About Love* and Rabbi Sharon Brous' *The Amen Effect*. I'll also take drop-in classes at the Shalom Hartman Institute, where I studied this summer.
- Add my energy to movements that promote shared society between Jews and Arabs. If all goes according to plan, Galit will attend one of two "mixed" schools in Jerusalem. She will attend school with Jews, Muslims and Christians. Classes are instructed in Hebrew, but she will take Arabic classes and learn about both Israeli and Palestinian culture. I look forward to getting involved as a parent at her school (if Galit lets me).
- Add my energy to movements in Israel that promote religious pluralism. The progressive Judaism that we practice at TBO is not sanctioned or funded by the Israeli government. We will attend Shabbat services at Kol HaNeshama, the premier Reform congregation in Jerusalem. We will also wake up early once a month to attend Rosh Chodesh services at the Kotel led by Women of the Wall. I am hoping to read Torah at one of their services, too
- 4 **Help my daughter build her own unique relationship with Israel.** I know Galit will make her own friends while we are there, but I am grateful to have a network of Israeli friends and their children who are excited to meet Galit and who represent the diversity of Israel's population: Jewish-Israelis, Palestinian-Israelis, folks who support a bi-national state in Israel, others who support West Bank settlement expansion, staunchly secular Jews, and Orthodox Jews, too. It is important to me to expose Galit to a variety of perspectives.
- 5 **Enjoy living life on Jewish time.** Shabbat and Jewish holidays in Israel are just so special. Even the cashier at the grocery store wishes you "Shabbat shalom."
- 6 **Nourish my soul through creativity.** I plan to work on my drawing and photography. I already have a membership pass to the Israel Museum and hope to explore all the art galleries in Jerusalem and Tel Aviv.
- 7 **Reset and relax.** While I have many things I hope to accomplish over my sabbatical, I also plan to enjoy some downtime. I strategically rented an apartment due to its close proximity to my favorite farm-to-table brunch. You can literally see the restaurant from my balcony.

Reflections

I frequently reminded myself that we all want the best for Temple Beth Or. At the start of my presidency, I dreaded getting up in front of groups. Yet that was part of my role, so I pushed myself, and over time I have become much more comfortable in the spotlight. I will be forever grateful for the opportunity to grow in that area.

Each president has their strengths and weaknesses and their own style. And each president faces different challenges. With the Capital Campaign underway, when I became president it was time to focus on the actual remodel. So the Remodel Task Force, competently headed by Melanie Field and **Harold Dash**, was formed. In the spring, Temple Beth Or became the beneficiary of an estate which included a house in great disrepair. Along with the remodel, dealing with that house became a major focus of my first year. Thanks to **Kathy Pickus**, our real estate agent, and those of you who helped with the house, the estate resulted in a significant boost to our Capital Campaign. Throughout my presidency, what I found was that time and time again when I needed help, someone stepped up. I am incredibly thankful to be part of such a caring, hard-working community. I cherish the new relationships and friendships I have developed over my presidency.



 - A: I thought we were? Haven't you heard of the Incredible Flying Davises? ;-)





Ruach & Ritual Committee

Most members are aware that **Rabbi Kort** will be away from TBO January through June 2025, on sabbatical. While we will need to adjust to TBO programs without her wise input and counsel, we will also benefit in many ways during her absence. Rabbi Kort is working diligently to ensure that we are prepared for leading services and programs while she is gone. Rabbi Kort, Ron Green and Pam Spitzer have already conducted workshops with TBO congregants to help us prepare to lead services and provide teachings. It is impressive how many members are willing to step up to the bimah and take on a leadership role!

Rabbi Kort will lead Shabbat services from afar one Friday per month. Almost immediately, we will benefit from what she is experiencing and learning while away.

At least one time per month, the congregants of TBO will step up to the plate to provide Shabbat service leadership. From opening prayers to d'var Torah teachings, our members will bring new perspectives, new voices and fresh ideas to Shabbat.

At least once per month, we will be joined by professional music leaders and rabbinate. All are familiar names and faces, taking on new roles.

And at least one time per month, TBO will be "dark," no Shabbat services provided either via Zoom or at a location. Shabbat still happens, though, even without a formal prepared service. The Ruach & Ritual Committee encourages you to have Shabbat on your own. Invite others to join you in lighting candles, discussing the week's Torah portion and singing songs. On these "dark" dates, we will provide a link to the week's Torah portion through the URJ website. This will include adult learning as well as how to engage tots. Challenge your family and friends to jump in, learn and celebrate Shabbat even without a formal gathering at TBO!

Remodel news

Here's the latest:

- We have received our demolition permit from the City of Everett. We have also received partial initial comments on our building permit application.
- We are expecting to receive our building permit and our public works permit later this winter/spring.
- The insurance claim deadline has been extended to April 16, 2025.
- As of this writing, the Task Force is awaiting an updated project cost estimate from the contractor that would reflect some cost savings modifications to our plan, including using a less expensive roofing material and removing the overhang by the entrance. Additional value engineering efforts may be able to further reduce costs.
- The Task Force discussed the presentation to be given at the December Semiannual Membership Meeting.
- We are preparing for a congregational vote on the project, authorizing the signing of a contract with the contractor, in early 2025.
